

Terms and Conditions – Newsletter sign-up competition – World Equestrian Games Herning 2022

1. The promoter is ECCO Europe AG whose registered office is at Rothusstrasse 17, 6331 Hünenberg, Switzerland, with company registration no. CHE-114.674.317 (hereinafter referred to as "ECCO").
2. The competition is open to residents of Denmark, Norway, Sweden, Germany, the Netherlands, United Kingdom and Finland aged 18 years or over, except employees of ECCO and their close relatives and anyone otherwise connected with the organization or judging of this competition.
3. There is no entree fee and no purchase necessary to enter this competition.
4. By entering this competition, an entrant is indicating his/her/their agreement to be bound by these terms and conditions.

6. Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.
7. The competition runs from 6th of August 2022. Closing date for entry will be the 17 of August 2022. After this date no further entries to the competition will not be considered.
8. No responsibility can be accepted for entries not received for whatever reason.

 - a. To enter the competition one has to sign up to the ECCO Newsletter through the URL mentioned in the above Terms and Conditions, providing ECCO with their full name (first and last name) and e-mail address.
 - b. When signing up to receive newsletters, you consent to all ECCO and ECCO Affiliates being allowed to send you e-mails, text messages (SMS) and regular mail containing information about ECCO's Products (shoes, bags and related accessories), services, contests and promotions ("Newsletters").
